When bank notes are paid into the SafePay™ NR2, they enter a completely closed and secure system. All notes are automatically authenticated and can be recycled as change for other customers. For collection, the notes are deposited into an ink-protected transportation cassette. This ensures their secure transfer from the checkout to the back office and simplifies the collection process for CIT. Even during refilling or maintenance, the notes are never exposed.

With SafePay NR2, cashiers are relieved of time-consuming back-office cash administration. Notes arrive checked and counted in the back office and cash totals are monitored online using SafePay Control software.

Suitable for traditional checkouts, self-service checkouts and payment stations, SafePay NR2 can be used as a single note payment solution for the whole store.

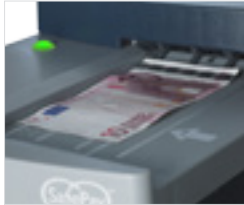

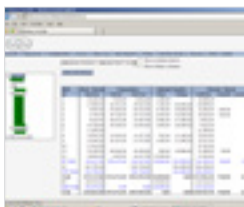

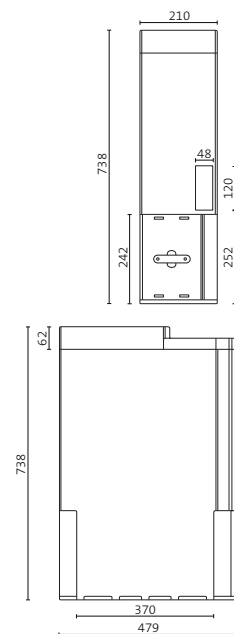
